

Terms and Conditions for the VDO Battery Promotion 2026 (the “Promotion”)

1 Organizer

The organizer of the Promotion is:

(hereinafter referred to as “AUMOVIO”).

Any questions, comments, or complaints relating to the Promotion must be directed to the above address.

2 Eligibility

2.1 Participation in the Promotion is possible as follows:

Participants must purchase a VDO-branded battery during the promotional period from September 1, 2026, to December 31, 2026.

After the purchase, participants must visit the promotional website: aftermarket.vdo.com/battery-promotion and upload their invoice no later than December 31, 2026, at 11:59 p.m., providing their personal details. The mandatory fields required for participation (invoice upload, first name, last name, street, house number, postal code, city, and e-mail address) must be completed accurately and in full. Otherwise, any entitlement to a reward will be forfeited.

The uploaded invoice must clearly show that the purchased product is a VDO battery participating in the Promotion and must also include the purchase date. Invoice items not related to the battery purchase may be redacted.

Participation is only possible online. Participation by post or by e-mail is excluded and will not be considered.

Photographing and uploading product packaging, or submitting packaging by post, does not qualify as participation and will not be considered.

Participation is free of charge.

2.2 The Promotion is open exclusively to natural persons residing in Germany or Austria. Participation under a false name or on behalf of a third party is not permitted. Multiple participations in the Promotion, including participation under different names, are not allowed.

2.3 Employees of AUMOVIO, affiliated companies within the meaning of Sections 15 et seq. of the German Stock Corporation Act (AktG), their family members, and any persons involved in the conception or implementation of this Promotion are excluded from participation.

3.1 The Promotion begins on September 1, 2026, at 12:00 a.m. and ends on December 31, 2026, at 11:59 p.m. Entries received after this deadline will not be considered, regardless of the reason for the delay. AUMOVIO Aftermarket GmbH cannot be held responsible for technical malfunctions such as failures of telephone networks, computer networks, electronic systems, computers, or data transmission problems.

3.2 The first 200 participants who upload a valid invoice will receive a VDO cooler bag.

3.3 AUMOVIO reserves the right to terminate the Promotion early or to extend its duration without prior notice and without stating reasons. This applies in particular if proper implementation of the Promotion cannot be guaranteed for technical or legal reasons. In such cases, participants shall have no claims whatsoever against AUMOVIO.

4 Notification of Participants

- 4.1 In connection with the Promotion, AUMOVIO is entitled to transfer participants' data to service providers for the purpose of delivering the rewards.
- 4.2 If delivery of a reward cannot be completed for reasons attributable to the participant, any entitlement to the reward shall expire without replacement.

5 Exclusion from Participation

AUMOVIO reserves the right, at its sole discretion, to exclude individuals from participation, revoke rewards already granted, and reclaim such rewards if there is reasonable suspicion of false information, manipulation, violation of these Terms and Conditions, or other unlawful conduct.

6 Liability

Participants acknowledge that AUMOVIO does not guarantee the availability of the websites through which participation in the Promotion is conducted, nor the availability of the content published on such websites. AUMOVIO reserves the right to restrict, in whole or in part, the availability of such websites or access thereto at any time, including without prior notice.

AUMOVIO shall not be liable for the insolvency of service providers or for any resulting consequences affecting the execution of the Promotion or the distribution of rewards.

AUMOVIO, its corporate bodies, employees, and agents shall not be liable for damages arising from errors, delays, interruptions in transmission, technical failures, service disruptions, incorrect content, loss or deletion of data, viruses, or any other issues related to participation in the Promotion, unless such damages are caused intentionally or through gross negligence by AUMOVIO. This limitation of liability does not apply to injury to life, body, or health.

7 Data Processing

The personal data collected in connection with participation in the Promotion will be processed by AUMOVIO Aftermarket GmbH solely for the purpose of administering and carrying out the Promotion. This includes, in particular, verifying uploaded invoices, preventing multiple entries, and shipping the promotional reward. Further information regarding data processing, including the legal basis for processing and participants' rights, can be found in the accompanying Privacy Notice.

8 Miscellaneous

- 8.1 Legal recourse is excluded.
- 8.2 These Terms and Conditions and the entire legal relationship between participants and AUMOVIO shall be governed exclusively by the laws of Germany.
- 8.3 Should any provision of these Terms and Conditions be or become invalid in whole or in part, the validity of the remaining provisions shall remain unaffected. The invalid provision shall be replaced by a legally permissible provision that most closely reflects the economic purpose and intent of the invalid provision. The same shall apply in the event of any unintended gap in these Terms and Conditions.
- 8.4 The place of performance and, where legally permissible, the place of jurisdiction shall be Frankfurt am Main, Germany. If a participant does not have a general place of jurisdiction in Germany or relocates their residence abroad after participating, the registered office of AUMOVIO shall likewise be agreed as the place of jurisdiction.
